Transportation Code Violation:

Family Disturbance:

19200 Lockridge Dr: A male was found to be causing a verbal disturbance. No criminal offense occurred but a report was generated to document the incident.

ALARMS – Contract patrol deputies responded to 1 local alarm at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 68 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.
