## **Summary of Events**

August Stats

Family Disturbance:

1300 Lemm Rd #2 - Known family member made threat to other family member. The family member was arrested for making threat in reference to a previous case. Charges were accepted and a warrant was issued.

200 E North Hill Dr – Family members had a verbal altercation. No criminal offense occurred.

Drug Possession:

18900 North Freeway – A traffic stop was conducted on a vehicle for a transportation code violations. During the course of the stop narcotics were located within the vehicle. Charges are pending lab testing of the narcotics.

Telephone Harassment:

19300 Whitewood Dr – Complainant reported harassing messages due to dispute with a contractor over money. There was no criminal offense at the time.

DWI:

19100 Tyrone St- Deputies received a call of a suspicious vehicle. Upon arriving on scene and making contact with the driver it was found that the male was intoxicated. The male was taken into custody of booked into the Harris County jail for driving while intoxicated.

ALARMS – Contract patrol deputies responded to 4local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 23 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded to 46 other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 3 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.
