#### Summary of Events

##### July Stats

##### Burglary of a Motor Vehicle

1100 Lynwood – Unknown suspect(s) made unauthorized entry into the complainant's unlocked vehicle and stole miscellaneous electronics.

600 E Cypresswood – Unknown suspect(s) made forced entry into the complainant's vehicle and stole unknown tools.

600 Ames Cir – Male suspect made unauthorized entry into the complainant's unlocked vehicle and stole miscellaneous items.

##### Criminal Mischief

1300 Lemm Rd #2 - Unknown suspect(s) damaged the complainant's vehicle over night. No items were missing.

##### Theft

200 E North Hill – The complainant reported items missing from inside of the residence and believes a family member took items.

##### Terroristic Threat

900 Lynwood- The complainant reported receiving threats online from an unknown subject.

#### Unauthorized use of a Motor Vehicle

200 E North Hill – Male reported locating his stolen vehicle as it entered the subdivision. The male crashed the truck causing no property damage. The male then fled on foot and attempted to enter two other vehicles, causing damage to one of them. Deputies arrived and were able to detain the male after a short foot chase. The male was booked into the Harris County Jail for Unauthorized use of a Motor Vehicle. Further charges pending on the male for vehicle thefts and burglaries which occurred outside of the neighborhood.

#### Motor Vehicle Accident

19200 Tyrone – Complainant reported being involved in a minor accident outside of the subdivision. The complainant advised the other driver fled the scene without stopping to exchange information. The complainant returned home to make an FSGI report.

19500 Whitewood Dr- A bicyclist was involved in a minor accident with a motor vehicle. One party was transported for minor injuries. Information was exchanged and an accident report was completed.

ALARMS – Contract patrol deputies responded to 3 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 36 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded to 68 other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS ACTIVITY – Contract patrol deputies responded to 2 suspicious vehicles and 9 suspicious person within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.
