Summary of Events

Burglary of a Motor Vehicle:

1200 Lynwood Dr – The complainant reported that two unknown subjects broke into the complainant's unlocked vehicles. The complainant was unable to provide a description of the suspects.

Theft:

600 Twain – The complainant reported a female subject stole packages front the front of the residence. Video footage was obtained but the suspect has not been identified at this time.

Family Disturbance:

400 Bickett Ln – Known family members were involved in an altercation. Charges were declined and parties were separated without further issue.

Transportation Code Violation –

19300 Lockridge Dr - A vehicle was stopped for multiple violations while traveling through the neighborhood. The driver was found not to have a valid license and did not have insurance. The vehicle was towed and the driver was cited and released.

19500 Lockridge Dr – A vehicle was stopped for expired license plates. During the investigation family arrived on scene. The family member was identified and found to have 14 misdemeanor warrants. The subject was taken into custody and booked into the Harris County Jail. The driver was cited and released.

19000 Casper Dr – A driver was stopped for running a stop sign. The driver was found not to have a valid license and did not have insurance. A family member arrived on scene in an attempt drive the vehicle away. This driver was observed arriving on scene while committing multiple violations. Further investigation revealed that the driver had a suspended license and had no insurance. Both vehicles were towed and the drivers were cited and released.

Other:

18600 Casper Dr – A report was requested to document a civil issues between contractor and customer

1200 Lynwood Rd- A report was requested do document a civil issue over property.

400 Artesia – An unknown subject struck the complainants mailbox and fled the scene. Video footage was obtained but license plate was unable to be obtained.

600 Turley – Complainant requested a report to document being scammed via Craigslist.

ALARMS – Contract patrol deputies responded to 8 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 47 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded 60 to other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 2 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.
